


Revenue and Expense Deferrals™ for Sage 300 helps companies with the amortization of maintenance and service related contract revenue and expense amounts over the life of the contract. Other application areas include subscriptions, memberships, school fees and more. Companies reap the benefit of compliance with the Public Company Accounting and Investor Protection Act of 2002 (also known as the Sarbanes-Oxley Act of 2002). Although not specifically covered under the Act, non-public entities are also finding that bankers, investors, and acquisition candidates are now conditioned to expect increased transparency and real-time disclosure, effectively placing a greater accounting and reporting burden on companies who are not legally obligated to comply with the Act. Revenue and Expense Deferrals helps companies with meeting these additional demands.

Revenue and Expense Deferrals can be configured to process transactions from any Sage 300 module, including 3rd party SDK applications, as long as they post their transactions to G/L and they support the Transaction Analysis and Optional Fields Creator module.

Functional Features

- Supports three deferral methods: Straight-Line, Declining Balance, and Manual.
- Recognizes equal amounts in each period.
- Support for G/L Account code change is added.
- Captures transactions earmarked for amortization in Sage 300 modules and third-party applications.
- Processing logic is based on G/L transactions only.
- Revenue and expense amounts are amortized and posted to designated "Deferred Revenue" or "Deferred Expense" accounts.
- Partial Deferral is allowed.
- Amortized amounts are "recognized" and posted back to G/L upon maturity, in predefined portions, according to the amortization terms defined in Options.
- Transactions can be put on hold, thus delaying recognition until they
 are manually or automatically released. Auto release date for on
 hold transactions can be specified (optional).
- Templates can be used for easy configuration of recognition settings in individual transactions.
- · Recognition schedule can be modified manually.
- Electronic files can be attached to transactions.
